However, on 16/04/21, the crew on board M/V "KIARA" – A CMA-CGM vessel - underwent a routine COVID check. 4 crew members were found affected. The vessel was hence isolated at anchor for 7 days, after which she was allowed to berth and proceed with the cargo ops.





 \Box **CONFINEMENT** : The massive gathering of people (more than 10 persons) is prohibited. It is obligatory for all citizens in the Albanian territory to wear a mask even in open spaces. The children younger than 11 years and other persons that cannot wear a mask on health reasons are excluded from this obligation. Currently there is a curfew during period <u>22</u>:00 – <u>06</u>:00.

□ NON ESSENTIAL BUSINESS' CLOSURE : Businesses are open, including bars and restaurants, which are required to respect safety protocols.

□ BORDERS' CLOSURE : Land borders of Albania with neighboring countries for the free movement of people are opened. Actually all nationalities are allowed to enter in Albania. Trucks and other cargo movement are allowed and continue normally. Passengers arriving from Greece and North Macedonia (by road and/or air) are required to stay at quarantine. This measure lasts until 3rd May 2021.

All seaports are open. There are no restrictions in handling of cargo vessels, ro-ro vessels, tankers and gas-carriers. Ferryboats vessels (including passengers) to/from Italian ports are allowed. Both shipping lines and passengers should respect the safety protocols. Actually all nationalities are allowed to enter in Albania. The yachts and other touristic boats are allowed in ports.

Returning to Italy

The ordinance, in force until April 30, 2021 provides that on returning to Italy it is mandatory to:

undergo a swab (molecular or antigenic) carried out within 48 hours before entering Italy, with a negative result; undergo health surveillance and fiduciary isolation for a period of five days, regardless of the result of the molecular or antigenic test referred to above;

undergo a further molecular or antigenic test at the end of the five-day isolation period

These provisions do not apply to those who fall under the conditions of exemption as set out in Article 51(7) Dpcm March2,2021.

<u>New ordinance in force until May 12, 2021 banning entry into Italy for travellers who have been in India</u> over the last 14 days. Residents of Italy will be allowed to re-enter with a swab test on departure and arrival and with a mandatory quarantine. Anyone who has been in India over the last 14 days and is already back in our country is required to undergo a swab test, by contacting the prevention departments.

Health Minister Roberto Speranza made this statement to explain the new measure.

Classification of Regions

(Last updated: April 26, 2021)

The Minister of Health, Roberto Speranza, on the basis of the data and indications of the Cabina di Regia/Control Room of April 23, 2021, has signed new Ordinances that will come into force from Monday, April 26.

The first Ordinance confirms the classification of Sardinia as a red area.

The instruction will be valid from April 14 and continue until further notice, the Religious Affairs Ministry said in a new set of directives issued on Monday.

Bangladesh fast running out of stock, the top authorities of the government have been frantically searching for Covid-19 vaccines from various global sources. Bangladesh might acquire additional doses of vaccines from COVAX through a purchase agreement, but the requisition must be submitted by April 24. The date for delivery of the vaccines is yet to be determined.
