THE PARISMAT MEETING

OR HOW TO SHOW THE EXPERTISE OF THE FRENCH MARINE AND AVIATION INSURANCE PLACE ACROSS THE WORLD WHILE ALLOWING YOUNG TALENTS TO GROW.

Organized by CESAM in close collaboration with the Organizing Committee, the Rendez-Vous ParisMAT aims to highlight the know-how and knowledge of all the players in Marine & Aviation insurance ecosystem operating on the French market.

The Rendez-Vous ParisMAT also makes it possible to strengthen contacts with other markets and to highlight the strengths of the French market on the international scene. Launched in 2009 in Cannes, the Rendez-Vous ParisMAT has been organized since 2012 in Paris, a world-renowned financial center.

Each year, more than 1 000 insurers and players (brokers, surveyors, average agents, shipowners, carriers, freight forwarders, logisticians, maritime lawyers, risk managers, French Insurtechs or even teachers and academics) from more than 40 countries, bring together, exchange and debate on developments in the Marine & Aviation Insurance market.

Current topics impacting the sector are presented and commented on, whether they concern international trade, the world of shipping, regulatory developments and those of risks; all aspects that can shed relevant light on the profession.

In June 2025, for two days, different round tables were organized around key themes such as:

- › Towards a new global trade landscape? ;
- › Artificial intelligence and neuroscience applied to aviation, with a perspective to other sectors of activity ;
- › Submarine cables (types of loss, insurability and sovereignty) ;
- › Inland freight theft through the supply chain (situation, statistics, modus operandi and prevention measures) ;
- › Space insurance challenges - evolution of insurers' risks and portfolios ;
- › Various different salvage possibilities for a sea vessel ;
- › Frequency jamming: what impact on world trade? ;

These are essential keys to understanding the issues and the future of the transport insurance market.

It is also during the Rendez-Vous ParisMAT that the Student Prize is awarded, rewarding each year the best dissertation written as part of a Master 2, on a subject relating to risks relating to or impacting the activity of Marine & Aviation Insurers.

In 2025, awards were given for research on "Racing boat insurance", as well as the Center for Maritime and Transport Law - University of Aix-Marseille – Faculty of Law and Political Science were rewarded.
